Summary:

The purpose of this program is to support the disaster preparedness, training, and education needs of Floridians. Awards will support efforts to engage citizens in all-hazards prevention, protection, response, and recovery.

Funding will support expenditures in the following categories:

- **Planning:** activities that engage the whole community in the development of a strategic, operational, and/or community-based approach to preparedness
- **Organization:** all-hazards emergency management operations, staffing, and other day-to-day activities in support of emergency management
- **Training:** activities that foster the development of a community-oriented approach to emergency management that emphasizes engagement at the community level, strengthens best practices, and provides a path toward building sustainable resilience
- **Exercise:** activities that design, develop, conduct, and evaluate exercises, including the hiring of full- or part-time staff or contractors/consultants
- **Equipment:** equipment that meets all the mandatory regulations and/or Federal Emergency Management Agency (FEMA)-adopted standards and is listed on FEMA's Authorized Equipment List (AEL), which can be found online at www.fema.gov
- **Management and administration:** activities directly related to the management and administration of program funding

Eligible applicants are:

- Units of local government, including counties and cities, fire tax districts, other tax districts, and regional planning councils
- State-supported community colleges, colleges, and universities
- Federally recognized tribes or nations

The funding agency anticipates that a successful application will be received from each of the Florida Division of Emergency Management's (FDEM's) ten regional county emergency management coordination teams, a map of which can be found online at www.floridadisaster.org/dem. If a viable application is not received from each of the ten teams, or if all applications submitted for a specific region score below the minimum of 60 points, the funding agency will move allocated funds to another region, general consideration funding area, or another program.

Priority will be given to applicants that demonstrate:

- High cost efficiency
- A high level of partnership activities
- Significant involvement in all-hazard emergency preparedness
- Strong sustainability plans to sustain the project after the award funding has expired
