## ACTION PLAN

Notice is hereby given that the City of Palm Beach will conduct public hearings on 4/3/25, at 6:00 P.M. in City Hall Council Chambers, 120 Malabar Road, SE, Palm Beach, Florida. The purpose of the hearings are to receive comments and take preliminary action on Community Development Advisory Board recommendations to Council concerning CDBG and HOME projects/activities proposed for the PY 2025 Action Plan. The U.S. Department of Housing and Urban Development has not yet announced the PY 2025 award amounts but based on last year's awards, the City anticipates receiving \$776,641 in CDBG entitlement funds and \$227,234.16 in HOME funds for the program year that begins on 10/1/25.

**COMMUNITY DEVELOPMENT OBJECTIVES:** The overall purpose of the CDBG program is the development of viable urban communities by providing decent housing and a suitable living environment and expanding economic opportunities, principally for persons of low/moderate income.

**HOME INVESTMENT PARTNERSHIPS PROGRAM OBJECTIVES:** The overall purpose of the HOME program is to provide decent affordable housing to persons of low/moderate income. The public comment period starts on March 18, 2025, through April 3, 2025. Comments provided during the comment period and at the public hearing will be considered and submitted to the U.S. Department of Housing and Urban Development (HUD) during the submission of the PY 2025 Action Plan.

All interested persons are invited and encouraged to attend the public hearings and make oral or written comments.
