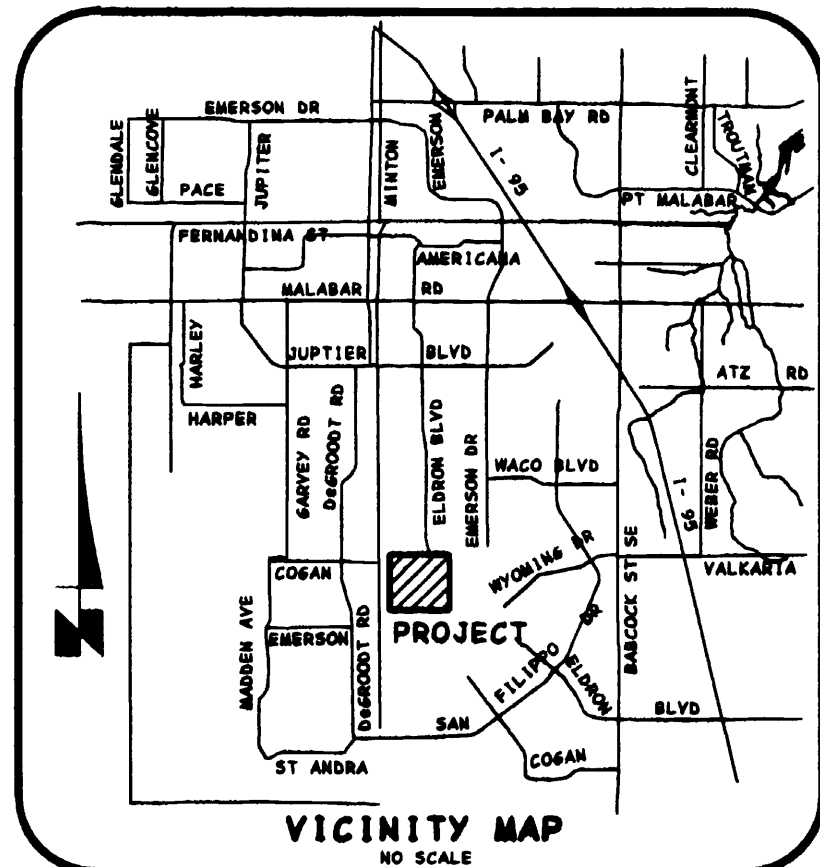

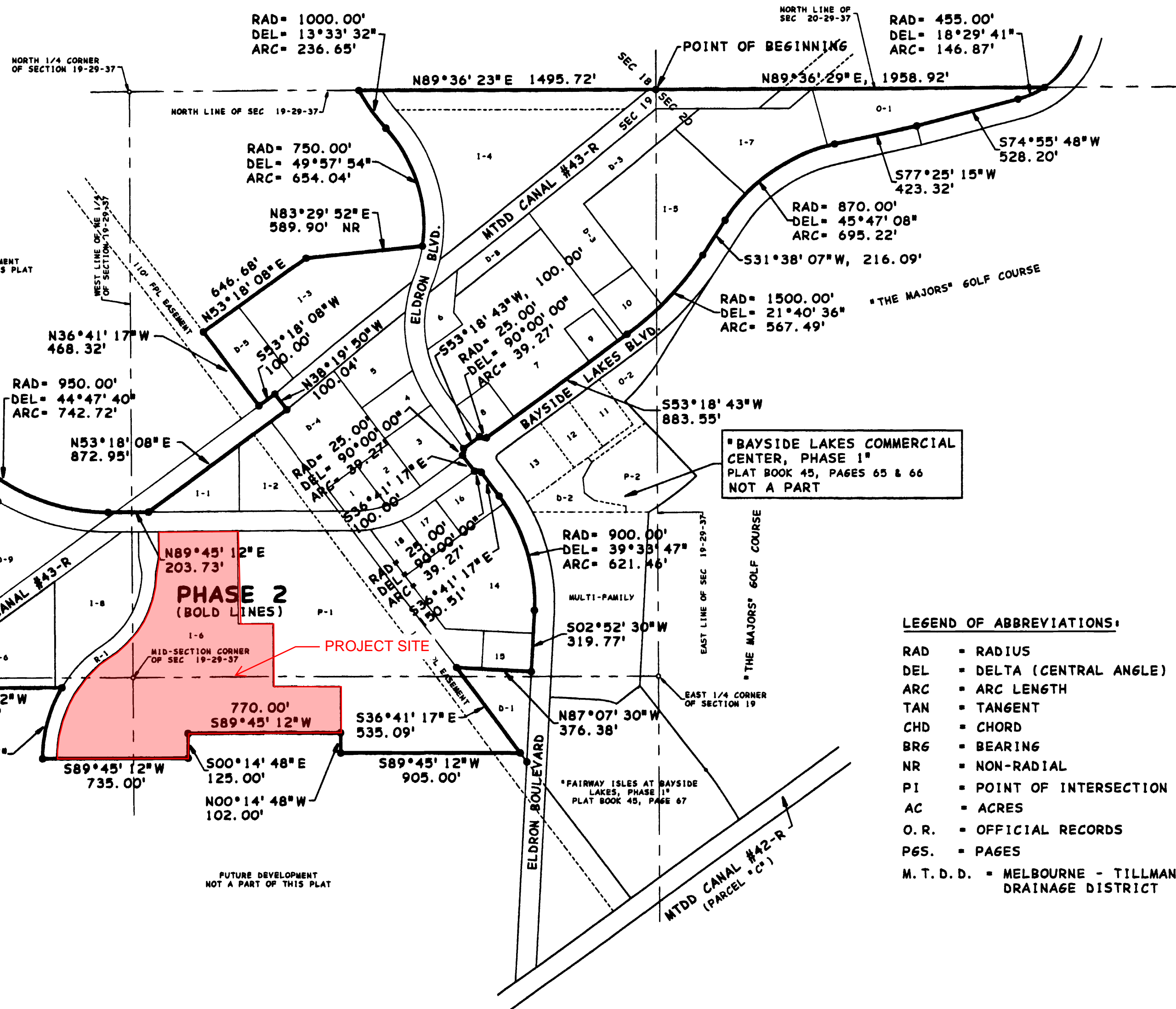
A PARCEL OF LAND BEING A PORTION OF "FLORIDA INDIAN RIVER LAND CO." SUBDIVISION OF SECTIONS 19 AND 20, TOWNSHIP 29 SOUTH, RANGE 37 EAST, RECORDED IN PLAT BOOK 1, PAGE 165 OF THE PUBLIC RECORDS OF BREVARD COUNTY, FLORIDA, BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

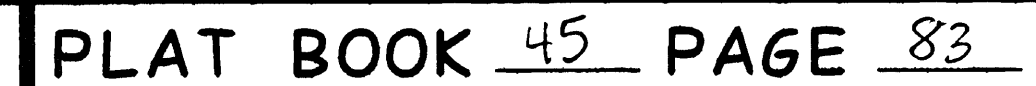

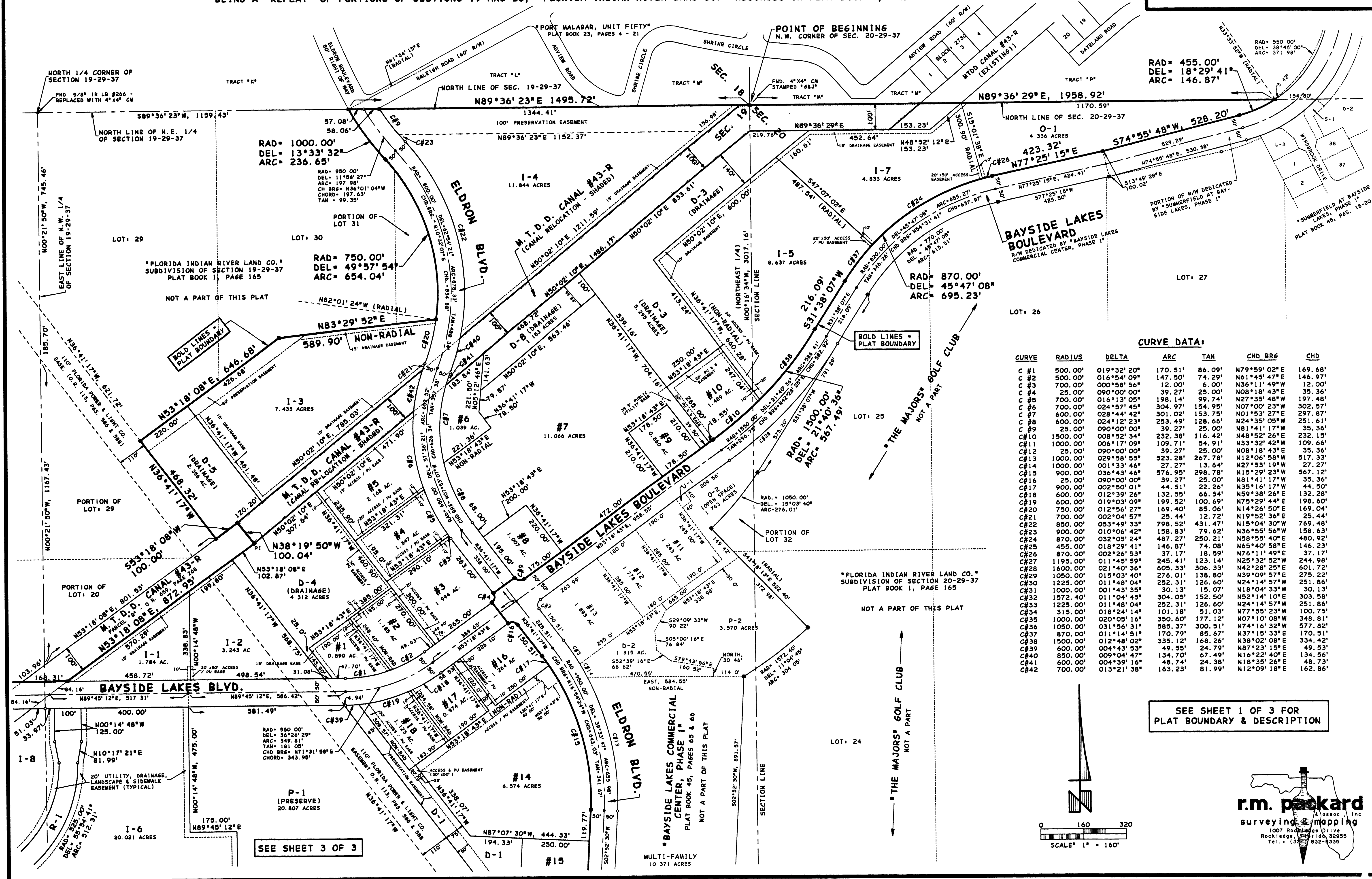

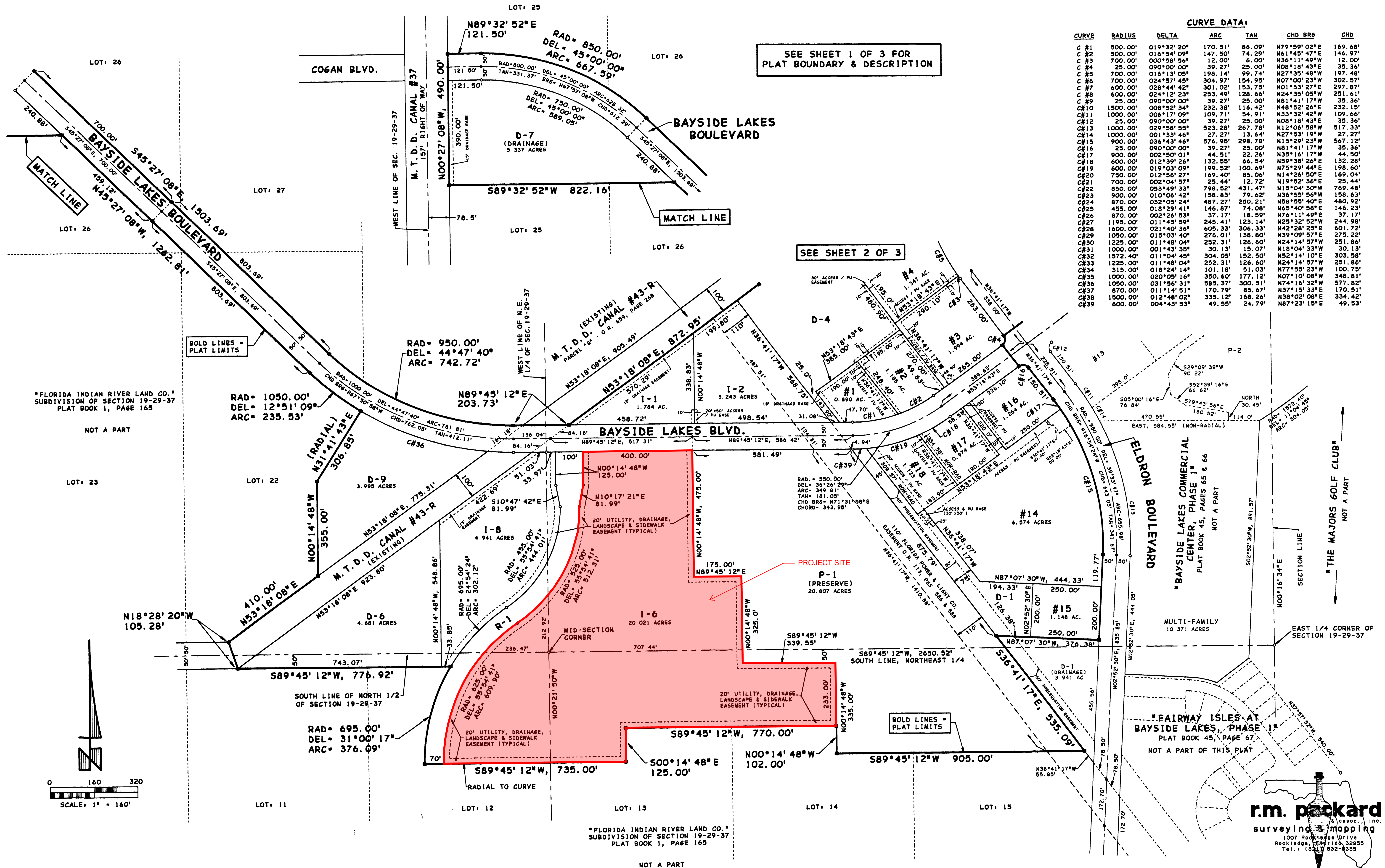
