Phase 4A – Chaparral Properties, LLC (Jake Wise, P.E., Construction Engineering Group, LLC, Rep.) - A Final Plat approval for a proposed 167-lot residential subdivision to be known as Chaparral P.U.D. Phase Four A. Tax Parcels 750, 751, 752, and 753 of Section 04, Township 29, Range 36, along with Tax Parcels 3 and 4 of Section 09, Township 29, Range 36, Brevard County, Florida, containing approximately 160.51 acres. Located south of Malabar Road SW, in the vicinity south of Abilene Drive SW</b>

### SUMMARY:

Applicant John Ryan, Chaparral Properties, LLC. (Jake Wise, P.E., Construction Engineering Group, LLC., Rep.) has submitted for a Final Subdivision Plat for a 167-lot residential subdivision to be called Chaparral P.U.D. Phase Four A located south of Malabar Road SW, in the vicinity south of Abilene Drive SW.

The proposed final subdivision plat for Chaparral P.U.D. Phase Four A substantially conforms to the preliminary plat for Chaparral P.U.D. Phase Four A-B and Five A-B (PS24-00001) and Phase Four A in the construction plans. The remaining phases from the preliminary plat are included as future development tracts.

To receive Final Plat approval, the proposal must meet the requirements of Section 184.08 of the Palm Bay Code of Ordinances. Upon review of the submitted materials, the Final Plat request is in substantial conformance with the applicable requirements of this section. Per Section 184.08, City Council can approve, approve with conditions, or disapprove such requests.
