Pursuant to the City Charter, as Rob Medina received more than fifty percent (50%) of the vote in the Primary Election, he was declared elected to the Office of Mayor, and his name would not appear on the General Election ballot. The candidates with the highest number of votes for City Council Seats 2 and 3 shall be candidates in the General Election to be held on November 5, 2024.

Motion by Mr. Weinberg, seconded by Deputy Mayor Felix, to certify the results of the Primary Municipal Election held on August 20, 2024. Motion carried with members voting as follows: Mayor Medina, Yea; Deputy Mayor Felix, Yea; Councilman Weinberg, Yea.
