RE:	Award of Bid: Digester 1 rehabilitation, North Regional Wastewater Treatment Plant – IFB 29-0-2024 – Utilities Department (L7 Construction, Inc., \$227,000).

SUMMARY:

The Utilities Department will be doing improvements at the North Regional Wastewater Treatment Plant (NRWWTP). The structural components of the walkways at digester 1 have degraded and require replacement. The improvements include replacement of walkways, stairs, bridge, supports and ladder at the digester. In addition, expansion joint material at the aeration basin will be replaced.

Two (2) bids were received in response to the City's solicitation. Procurement staff reviewed the bids for responsiveness. Utilities staff evaluated the bids for responsibility and ability to perform the scope of services. The low bid is acceptable to the Department.

Staff recommends L7 Construction, Inc., as the contractor for the replacement of the NRWWTP Digester No. 1 Rehabilitation in the amount of \$227,000.
