

21. Consideration of travel and training for specified City employees (Building Department).

RE: Consideration for approval of travel and training - Building Department (\$1,490).

SUMMARY:

The Building Department is requesting approval for Building Code Compliance Inspector, Mayra Leakakos, to travel overnight to attend the Fundamentals of Code Enforcement course located at 15 North M Street, Lake Worth, FL 33460 from September 9 - 13, 2024. Hotel accommodations will also be requested for four (4) nights.

This overnight travel was not in the Fiscal Year 2024 approved travel and training spreadsheet. Mayra Leakakos was transferred to the Building Department on April 1, 2024 when her position in the Fire Department was eliminated. Mayra must obtain Florida Association of Code Enforcement (F.A.C.E.) Fundamentals of Code Enforcement Certification within 12 months from date of hire.

Meal & Incidentals will be estimated at \$46.80 per day for five (5) days, totaling \$234. Hotel for four (4) nights will be estimated at \$151.50 per night, totaling \$606. Registration and Exam fee for the F.A.C.E. course is \$650. The total estimated cost of travel will be \$1490. Funds are available in Building Department Education Surplus account #451-0000-220-1024.
